

THE BEST STATE FOR BUSINESS

Whether it's tax and regulatory reform, talent or quality of life, Arizona is tops. The state's focus on business is simple: keep regulation low and taxes light. This makes Arizona a very affordable place to start, grow and scale a business. The ACA's targeted financial programs are an added benefit.



QUALITY JOBS TAX CREDIT

Provides up to \$9,000 of income or premium tax credits over a three-year period for each net new job to the state and concurrent qualifying capital expenditures.



QUALIFIED FACILITY TAX CREDIT

Provides refundable income tax credits up to \$20,000 per qualifying net new job to eligible manufacturing companies that invest in one or more qualifying facilities.



INTERNATIONAL OPERATIONS CENTER

Transaction Privilege Tax (sales tax) and Use Tax exemption for utilities for a facility with a minimum annual investment of \$100 million and at least \$1.25 billion over 10 years, with at least \$100 million invested in new renewable energy facilities that produce energy for selfconsumption.



JOB TRAINING GRANT

Grant to reimburse a portion of qualifying costs associated with hiring and training of net new employees.



ADDITIONAL DEPRECIATION

Accelerates depreciation to substantially reduce business personal property taxes.



CORPORATE INCOME TAX APPORTIONMENT

100 percent electable sales factor for multistate corporations.



EXEMPTION FOR MACHINERY AND EQUIPMENT

Provides Transaction Privilege Tax (sales tax) and Use Tax exemptions for machine and equipment used in manufacturing and R&D.



EXEMPTION FOR ELECTRICITY

Provides businesses principally engaged in manufacturing or smelting operations with state and county Transaction Privilege Tax (sales tax) and Use Tax exemptions in connection with purchases of electricity or natural gas.



FOREIGN TRADE ZONE

Provides approximately a 72 percent reduction in property taxes for property located in a foreign trade zone.



MILITARY REUSE ZONE

Provides property tax reductions and Transaction Privilege Tax (sales tax) exemptions to qualifying projects located in an MRZ.



HEALTHY FOREST ENTERPRISE PROGRAM

Provides Transaction Privilege Tax (sales tax) and Use Tax exemptions for qualifying equipment and fuel, as well as workforce training and new job income tax credits and property tax reductions for companies involved in improving the health of forests.



RESEARCH AND DEVELOPMENT

Provides income tax credits for increased R&D activities conducted in the state. Additional tax credits are available for R&D executed in collaboration with state universities.



COMPUTER DATA CENTER PROGRAM

Provides Transaction Privilege Tax (sales tax) and Use Tax exemptions at the state, county and local levels, on qualifying purchases of CDC Equipment.



RENEWABLE ENERGY TAX INCENTIVES PROGRAM

Provides property tax reductions to companies that are expanding or locating in Arizona and that are engaged in renewable energy industries.



RENEWABLE ENERGY PRODUCTION

Provides income tax credits to utility-scale generation systems based on the amount of electricity produced annually for a 10-year period using solar or wind energy.



COMMERCIAL/INDUSTRIAL SOLAR

Provides income tax credits for the installation of solar energy devices at Arizona business facilities.
